WHEN VISITING OUR LOCAL BUSINESSES


- Abide by all safety guidelines;
- Respect the 2 metre (6 feet) physical distancing;
- No unnecessary stops in our communities;
- Do not linger and visit outside businesses or in public spaces.

PLEASE DO NOT:

- Tour our neighborhoods and visit private residences;
- Visit or stay at any facility that is closed;
- Camp on First Nation Settlement Lands (ex. FNNND Nash Creek, Ethel Lake Outpost, etc.) without permission;
- Leave behind garbage, waste, sewage, etc. on our lands and waters.

When you are travelling within the Traditional Territory of First Nation of Nacho Nyak Dun/Mayo, YT

We continue to have our COVID-19 check-stop that we kindly ask those passing through to understand our purpose is for potential contact tracing to ensure community safety and the health of our most vulnerable. You will be greeted by friendly flaggers who collect basic data and this information is not shared with anyone but only aggregate numbers for statistical purposes. We thank you for respecting our duty.



- 1. Please be advised that our Government office is CLOSED to the public. You can call reception at 867-996-2265 for guidance.
- 2. Mushroom pickers please seek "Guidelines and Information for Harvesting Morel Mushrooms" on FNNND's Facebook page or contact NND's Land Dept. at 867-996-2265 ext.144 to learn more.
- 3. Be responsible when using fire (exercise caution, ensure that you have fire permits & are aware of any Yukon fire bans, etc.). Report wildfires to YG's Fireline at 1-888-798-3473. Yukon First Nations Wildfire is also a great resource plus more and they can be reached at 867-667-7258.
- 4. If you want to camp on or explore through First Nation Settlement Lands you need permission from the NND Lands Dept whom can be reached at 867-996-2265 ext.144 or landsmanager@nndfn.com

To other travelers passing through

(people from outside the Yukon allowed to transit through to or from Alaska or NWT):

Please abide by the 24-hour limit ordered by the Government of Yukon to pass through our territory.

- Please stay on the route directed by the Governments of Yukon and Canada.
- Please do not stop in our community unless you have an emergency.
- Please adhere to all other Canada and Yukon orders and measures.
- Respect all guidance listed here.



Six Steps to Staying Safe



Physical distancing – keep 2 metres away from everyone who's not a member of your household





Don't gather in groups of 10 or more people and remember to keep 2 metres apart



Wash your hands frequently with soap and water
