## Application Form – Boards and Committees

The Umbrella Final Agreement (UFA) provides that the Council of the Yukon First Nations (CYFN) or the Yukon First Nations or affected Yukon First Nations are responsible to nominate persons for appointment to the 10 UFA boards and committees that are responsible to undertake specific functions relating to the implementation of the UFA and 3 non-UFA boards and committees that are listed on the last page of this form.

CYFN administers the process for Yukon First Nations applying to these 13 boards and committees and advances nominations of Yukon First Nations to the Ministers responsible for each respective board or committee. This process was established to enable Yukon First Nations to contribute to the mandates prescribed in the Umbrella Final Agreement (UFA) and to ensure that Yukon First Nations are represented on key boards and committees.


